iv. 5" Dia Natural Gas MDPE pipeline along NH-19, Etawah to Chakeri (Left Side) from Ch. 439+460 to Ch. 449+100 (BPCL Darshan Filling Umran Rania to near Ghatampur distributory Raipur, approx. 9.640 Km.

Sir.

This is regarding the approval for permission for laying of (i) 8" Dia Natural Gas Carbon Steel Pipeline & 5" Dia MDPE along NH-19, Etawah – Chakeri (Right Side) from Ch. 432+360 to Ch. 452+760 (Shriyam Honda Motors Akbarpur to Bidhanu Canal Road Kisan Nagar) 20.400 Km. & Ch. 432+360 to Ch. 449+800 (Shriyam Honda Motors Akbarpur to GPL Factory Raipur) 17.440Km. ii.8" Dia Natural Gas Carbon Steel Pipeline with 5" Dia MDPE pipeline across National Highway -19 (Etawah to Chakeri Road) at Ch. 446+530, approx. 0.060 Km. iii. 8" Dia Natural Gas Carbon Steel Pipeline with 5" Dia MDPE pipeline across National Highway – 19 (Etawah – Chakeri Road) at Ch. 446+530, approx. 0.060 Km. iv. 5" Dia Natural Gas MDPE pipeline along NH-19, Etawah to Chakeri (Left Side) from Ch. 439+460 to Ch. 449+100 (BPCL Darshan Filling Umran Rania to near Ghatampur distributor Raipur, approx. 9.640 Km. in the State of Uttar Pradesh is hereby accorded by Competent Authority with direction to follow the MoRT&H Circular No. RW/NH-33044/29/2015/S&R(R) dtd. 22.11.2016. Further, Competent Authority has authorized Project Director on behalf of NHAI for signing of License Agreement with the applicant approval is subject to ensure following compliances before issuing permission for laying of natural gas CS pipeline:

 The NOC shall be valid upon the successful realization of the requisite fee in "Bharat Kosh" through online and after confirmation of deposition by RPAO, MoRT&H, Lucknow.

- The crossing/ laying will be done as per the proposed / agreed location route and as per proposed layout plan.
- The License shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
- Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- v. Undertaking to the following effect may be submitted and made part of the agreement:
 - a) Three copies of "As Laid Drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.
 - The permission may be terminated immediately on violation of the agreed terms and conditions.
 - c) The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.
 - d) Ensure that the submitted Agreement is in prescribed format as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the applicant, and BG be obtained as per the Circular.
 - e) Work programme may be submitted and ensure timely completion.
 - f) The compliance of various undertakings given by the Applicant may be ensured before and after signing of License Agreement, as the case may be in the interest of Safety of road users and NHAI.
- vi. Laying work should be carried out through HDD method.
- It shall be the responsibility of the applicant to ensure the safety and manoeuvrability of Highway Traffic during laying of OFC Cable duct.
- viii. The approval is based on the submission made by the Applicant as verified by the PD, PIU-Kanpur. The applicant is responsible for details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- ix. In view of any future development requiring necessary alteration, including complete removal or shifting of the Gas Pipeline, the same shall be carried out by the applicant at its own cost to the satisfaction the Highway Administrator.
- In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
- xi. IRC:98-2011 be complied wherever applicable.

Further, the BG No. OGT0009200044027 amounting to Rs. 17,44,000/- issued by IndusInd Bank 22.06.2020 valid upto 21.06.2021, if the work is not completed within time, the same shall be extended by the applicant.

In view of above, it is requested to furnish all the above documents/ undertakings at the earliest, so that the agreement for above work may be executed. It is further requested not to start any construction activity before execution of the agreement.
