### **Joint Site Inspection Report**

1. A proposal has been received by this office from National highway infrastructure development Corporation limited for diversion of forest land under forest (conservation act) 1980 for nonforest purpose. The project envisages diversion of **3.254935** Ha. of the forest land diversion in Favour of General Manager(P) NHIDCL for Construction and Upgradation to 2-lane with paved shoulder from design Km. 31.449 (Khellani) to Km 51.700 (Prem Nagar) of 20.251 Km. length on Khellani-Kishtwar-Chatroo section of NH-244 in the Union territory of Jammu and Kashmir under forest range Kellar, Chiralla Bhadarwah Forest Division. Site inspection of land involved in proposal has been done by the undersigned on Dated 15.09.2021.
2. On inspection of the site, it is found that land required by the user agency is Forest land measuring **3.254935** Ha.
3. The requirement of land proposed by user agency in Col-2 Part-1 is unavoidable and barest minimum.
4. Rare/Endangered/Unique species of Flora and Fauna found in the area, are Leopard, Jungle Foul, black bears & porcupine etc exists in the area. The said proposal may not affect their survival.
5. No protected/reserved/heritage site/defence establishment etc is in the Proposed diversion area.
6. No violation of the act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent authority.

#### **Specific Recommendation:**

The proposal may be accepted as per provision of Forest (Conservation) Act 1980 forest land diversion for non-forest purpose Construction and Upgradation to 2-lane with paved shoulder from design Km. 31.449 (Khellani) to Km 51.700 (Prem Nagar) of 20.251 Km. length on Khellani-Kishtwar-Chatroo section of NH-244 in the Union territory of Jammu and Kashmir for public interest.
