A Proposal has been received by this office from M/s Indraprastha Gas Ltd New Delhi for Laying of 12" & 8" dia natural gas pipe line at avarious roads, Khatoli by Pass to Rana Chowk, NH-58 km. chainage 102.050 to 113.440, Suzroo Chowk, to Rana Chowk, PWD raoad km 3.000 to 0.000), Charthawal Moud to Pinna by pass PWD chainage 71.900 to 69.400, total length 16.890 under (FCA-1980) of 0.8485 ha. of Protected forest land for non-forestry purpose. The Project envisages the use of forest land for Construction of Approach Road in Mannavarpur Khurad, Mansurpur, Ghasipura Tehsil- Khatouli and Village- Jadouda, Muzaffarnagar Tehsil- Sadar in Disst. Muzaffarnagar.

The site inspection of the land involved in the proposal has done by me on dated. 09/04/2021
