निरीक्षण टिप्पणी

दिनांक-06.09.2017 को श्रीमति विभा सिंह, पति -श्री छत्रपति कुमार सिंह, ग्राम- फारछहिया, पोस्ट- कोहबरवा, थाना+प्रखंड- सोनवर्षा, खाता संख्या- 59,159, खेसरा संख्या- 999, 1000, 1001 एवं 1002, मोजा-योगबाना, थाना- बथनाहा, जिला -सीतामढ़ी के अन्तर्गत BPCL का पेट्रोल पम्प (रिटेल आउटलेट) के निर्माण स्थल/स्थापित किये जाने वाले प्रस्तावित भूमि अंचल कार्यालय, बथनाहा का पत्रांक-74/मु० दिनांक-16.09.2016 के अनुसार आवेदिका के द्वारा लीज पर लिया गया जमीन का स्थलीय निरीक्षण वनों के क्षेत्र पदाधिकारी, सीतामढ़ी के साथ किया गया। प्रस्तावित स्थल एन०एच०-77 सीतामढ़ी-सोनवर्षा मुख्य पथ से सटे पूरब दिशा में स्थित है। वर्णित स्थल का आवेदिका द्वारा नक्शा एवं फोटोग्राफ कार्यालय में समर्पित किया गया है। जिसे इस निरीक्षण टिप्पणी के साथ संलग्न किया जा रहा है। पूरब एवं पश्चिम दिशा में आवेदिका द्वारा लीज पर लिया गया जमीन है। पश्चिम दिशा में एन०एच०-77 सीतामढ़ी-सोनवर्षा मुख्य पथ है। प्रस्तावित भू-खण्ड से पहुँच पथ (Approach Road) में कोई सरकारी पेड़/वनस्पति और जीव की दूलर्भ/लुप्तप्राय प्रजातियाँ अथवा कोई संरक्षित पुरात्तवीय/रक्षा प्रतिष्ठान स्थित नहीं है। प्रस्तावित स्थल से उत्तर दिशा में लगभग 200 मीटर की दूरी पर विद्यालय स्थित है। प्रस्तावित स्थल के आस-पास घनी बस्ती नहीं है। जनहित में रिटेल आउटलेट पेट्रोल पम्प निर्माण/स्थापित करना उपर्युक्त होगा।
