

SITE INSPECTION NOTES OF SRI. M. PRAKASH, S.F.S., FOREST DIVISIONAL OFFICER, MULUG DIVISION, MULUG ON DT: 25.06.2019.

The Prl. Chief Conservator of Forests (Head of Forest Force) Telangana, Hyderabad vide Rc. No. 5350/2019/FCA-1 Dt: 02.04.2019 and instructed to inspect the proposed diversion of 0.4778 Ha of forest land in Mulug Forest Divisions of Mulug District in favour of M/s Reliance JIO Infocomm Limited for laying of Optical Fiber Cable along the road side and within the existing Right of Way and submit the proposals with specific recommendations and findings in Part – II of the proposals through the Chief Conservator of Forests, Warangal at the earliest.

Accordingly a specific report was obtained from the Forest Range Officers, Pasra and Medaram and the area to (0.3994 Ha + 0.0784 Ha = 0.4778 Ha). Accordingly, I have inspected the proposed area of Reliance JIO Infocomm Limited on Dt: 25.06.2019 and found that the report of the Forest Range Officer, Mulug is justified. The area is falling adjacent to the Compt. Nos. 307, 358, 365, 367 and 368 in Karlapally, Moddulgudem, Amruthanda East and Oddugudem East Beats respectively of Bandal Reserve Forest Block of Pasra Range and Compt. Nos. 499, 500 of Kothur Beat of Medaram Range of Mulug Division. The proposed Optical Fiber Cable to be laid along the road side within the existing Right of way. No tree growth is involved.

It is falling in Bandal Reserve Forest Block in Compt. Nos. 307, 358, 365, 367 and 368 in Karlapally, Moddulgudem, Amruthanda East and Oddugudem East Beats respectively and the length of line in forest is 9983.81 Mts and width is 0.4 Mts in Pasra Range and in Compt. Nos. 499 and 500 in Kothur Beat and the length of line in forest is 1959.77 Mts and width is 0.4 Mts in Medaram Range making a total of 0.4778 Ha in Mulug Division. The proposed area having less than 0.4 density. The area required by the user agency is as follows.
