A proposal has been received by this office from **18/04/2023** for diversion (under FCA-1980) of 0.1817 ha. Of forest land for non forestry purpose. The subject envisages the use of forest land for "Diversion of 0.1817 hectare Forest Land for Construction of Approach Road for Proposed Indian Oil Corporation Ltd. Retail Outlet on Bikaner - Sri Ganganagar Road (NH-62) between KM Stone No. 189-190 (Change: 189.692 to 189.727) RHS in Kila No. 9 & 10 Murbba No. 11 at Village - 17 STB, Tehsil- Suratgarh, District- Sri Ganganagar, Rajasthan"
