

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF
(For the Forest land to be diverted under FCA)

Name of Project: Widening and Curve Improvement on Existing Road Alignment between Existing chainage 17.350km to 19.600km of Kishangarh-Hanumangarh Mega Highway Project. Village-Chakbeer, Tehsil-Roopangarh, District-Ajmer (Rajasthan).

A proposal has been received by this office from **Executive Engineer, Public Works Department, Division-Ajmer (Raj.)** for diversion (under FCA-1980) of **Widening and Curve Improvement of Kishangarh - Hanumangarh Mega Highway, Ajmer**. Forest land to be diverted 4.47 of forest land for non forestry purpose. The subject envisages the use of forest land for **"Widening and Curve Improvement of Kishangarh - Hanumangarh Mega Highway, Ajmer**.

The site inspection of the land involved in the proposal has been done by me on dated**03/12/2018**.....On inspection of the site; it is found that land required by the user agency is a forest measuring **4.470 ha...** Forest land used of forest block **Sursura Kabriya (PF)**.
