The Deputy Conservator of Forests, Hassan District, Hassan has inspected the proposed area on 19-04-2021 and reported that the proposed area falls in Dry Deciduous forest having Eco –Class-III consisting of tropical drydeciduous forest with density of 0.4. This forest includes area of unique flora and fauna with biological diversity and genetic resources apart from many medicinal herbs and shrubs. The area is home for wild fauna like Wild boar, Rabbit, Leopard, Sloth Bear etc., and common avifauna. The proposed forest land also doesn't come under wildlife sanctuaries and national parks, biosphere reserve & tiger reserve. The proposed area is not part of elephant habitat. Since, the proposed project is for providing Internet Connectivity in rural areas and Connecting Gram Panchayath under Digital India program of GOI.

The proposed area comes within Kattaya Kaval reserve forest area. The land required for the project is unavoidable and barest minimum for implementation of the project.

The Deputy Commissioner, Hassan District, Hassan had given certificate as per Check list no.3 (Appendix No.2) that there is no alternative suitable non forestland is available for laying BSNL of cable in Hassan-Kattaya route, Hassan District, Karnataka for this project.

Spot inspection by the undersigned was conducted on 20-5-2021 in Kattaya Kaval Reserve forest. Since the proposal project is for providing internet connectivity in rural areas and connecting Gram Panchayath under Digital India Program of GOI. the project may be accepted. The result of spot inspection is recorded in PART-III.
