
### **INSPECTION REPORT**

The site for proposed Construction and Development of Dwarka Expressway (NH-248BB) from Km 20, NH-8 (near Shiv Murti, Delhi) to Km 40, NH-8 (near Village Khirki Dola, Gurugram) in the NCT of Delhi: Package-1- Shiv Murti to Delhi/Haryana Border (Km 0.000 to Km 5.300) was inspected along with the Dy. Conservator of Forests (West) and the representatives of User Agency on 06.03.2019.

The proposed construction site is roadside plantation along an existing road. The project is site specific and will lead to decongestion of traffic which will help in reduction of air pollution in Delhi. There are 2751 trees over an area of 10 ha. at the proposed construction site.

The User Agency has earmarked 10 Ha. land in village Indrapath, near Sarai Kale Khan Yamuna Bridge, behind PWD office, NH-24, Delhi for undertaking Compensatory Plantation. The site has been found to be suitable for undertaking Compensatory Plantation.

The said construction is site specific and will lead to decongestion of traffic.
