10. Vegetation:-



Maximum effort shall be made to minimise the felling of existing trees. Dwarf species of trees shall be planted along the corridor.**

**The removal of trees shall not have much impact on eco-system as the same shall be mitigated by planting ten times more than the tree felled. Every care will be taken up for restoration of loss of vegetation and other related ecosystem of the area.**
