FIELD INSPECTION NOTES OF THE FIELD DIRECTOR PROJECT TIGER, KAWAL TIGER RESERVE, NIRMAL OF THE AREA PROPOSED FOR THE 2ND RENEWAL OF INDARAM MINING LEASE OVER 929.29 HA OF FOREST LAND IN INDARAM RF, MANCHERIAL RANGE OF MANCHERIAL FOREST DIVISION ON 11.01.2021

Inspected the area proposed for the 2nd Renewal of Indaram Mining Lease over 929.29 Ha of forest land along with the concerned GM of SCCL, District Forest Officer, Mancherial , Forest Divisional Officer, Mancherial and staff. The said proposed forest land is located in Compt. Nos. from 698 to 701, 703, 706 to 709 and 711 to 713 in Indaram RF, Mancherial Range of Mancherial forest division. The legal status of the forests is Indaram RF notified U/s 18 of Hyderabad Forest Act, Gazette No.9, dt: 7th Bahiman 1349F.

That, the proposed area is not important from archaeological point of view. The said area does not fall in any National Park, Wildlife Sanctuary, Bio Sphere Reserve, Tiger Reserve, Elephant Corridor, etc., but movement of tiger and other wildlife is reported in the said area and is presently covered in tiger landscape.

The area is mostly plain to undulating at some places. The important flora found on the surface of the proposed are mostly Anogeissus latifolia, Azadiracata indica, Chloroxylon swietenia, Cleistanthus collinus, Diospyros Melanoxylon Spp, Grewia latifolia, Madhuca indica (Bassia latifolia), Ougenia oojeinensis, Tectona grandis, Terminalia tomentosa, Terminalia belerica, Terminalia arjuna and Zizyphus xyloporous. The area is mostly covered with shrubs.





During the field visit, the GM and other authorities of SCCL were not agreeing to the version of encroachment as reported earlier. Inspected the boundary at F14 pillar of the said proposed area for lease at Dubbapally village shivar. Also inspected the location of surface rights structure at RK 8 newtech and are inspected and a pillar was also noticed as per the map prepared by the SCCL.

The Field Director Project Tiger, Kawal Tiger Reserve, Nirmal has requested the SCCL authorities to demarcate the areas used as surface rights on ground and the Forest Divisional Officer & staff to verify correctness regarding the location and area as per earlier approvals or permissions.

Accordingly, after the completion of the said exercise by the District Forest Officer and Forest Divisional Officer and in case if there is no encroachment / violation the file will be processed for 2nd renewal of said Indaram mining lease.
