The Project envisages the use of forest for Construction of Choudhary Charan Singh Kavadi Marg, RHS Side in Dhamat, Jamalpur, Gurupur In Tehsil Sadar and , Kamhera, Nagla Mehrdad, Basera, Nirgajni, Belda, Mohdmadpur Majra, Behda Thuru, Bhopa, Nagla Buzurg, Joli, Dukheri, Kantka, Mandord, Nagla Kabir, Chittora, Khera Moukpur, Nauna, Sarai Rasoolpur, Bhainsi, Satheri, Mohdmadpur Maffi in Tehsil- Jansath and Village- Jadouda, Muzaffarnagar Tehsil- Sadar in Dist. 
