

Site Inspection report of DCF

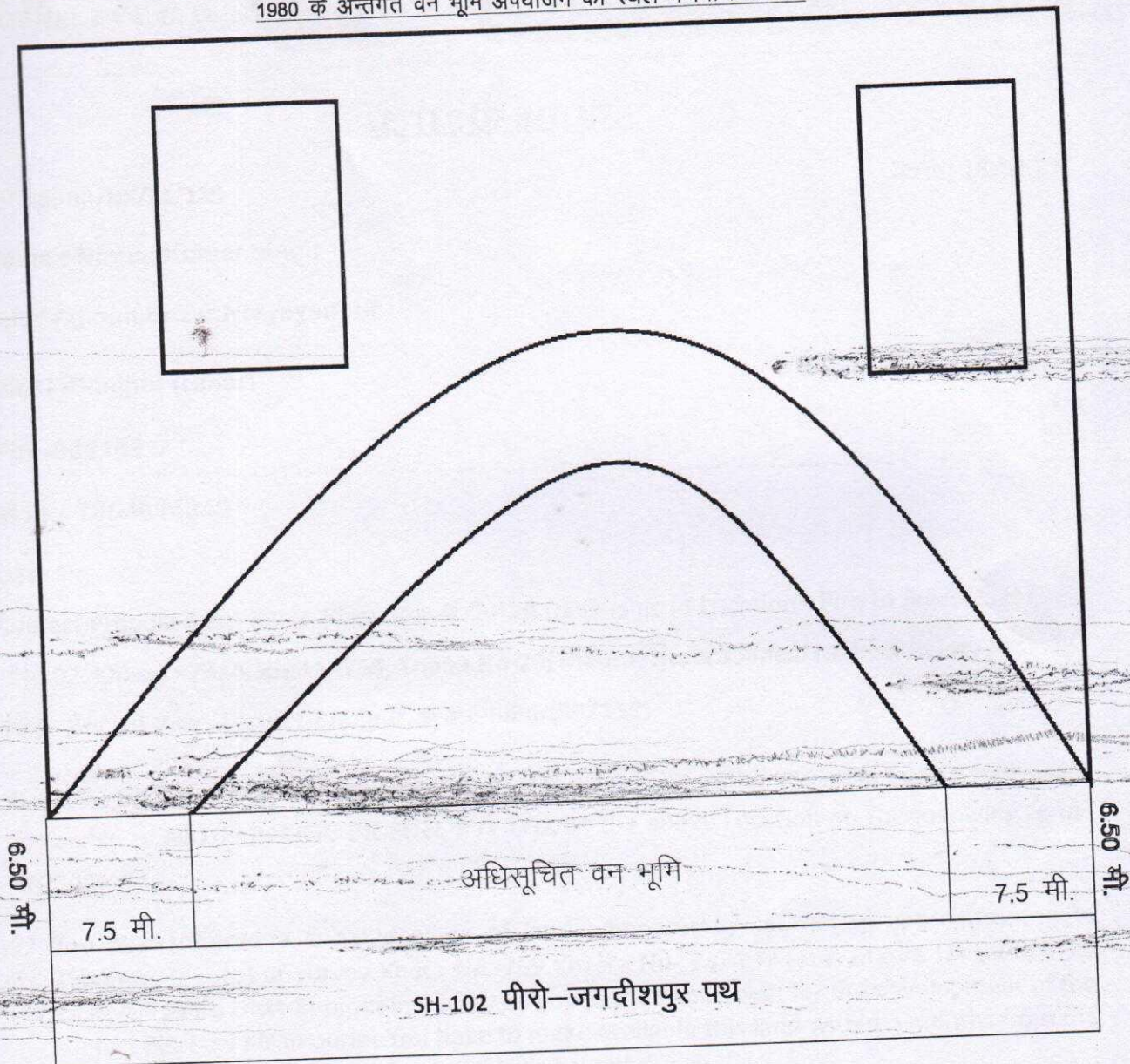
For the purpose of construction of retail outlet, a proposal for diversion of **0.00975 ha** forest land has been submitted by Shri Nirmal kumar Singh under the Forest Conservation Act, 1980. The site has been inspected in the presence of the user-agency. The proposed retail outlet is on SH-12 Piro-Jagdighpur Road – which is declared as Protected Forest vide Government of Bihar notification no.189E/190E, dated 16.02.1994. The retail outlet is proposed to be established on Khata no: 759 Plot no: 7324, Thana no: 26, Thana: Piro, Mauza- Jitora Jungle Mahaal, District: Bhojpur on personal land. For building access roads (entry/exit) connecting the retail outlet with the SH-12 Piro-Jagdighpur Road, the proposal has been submitted to divert the forest land falling adjacent to the said site road. There are no trees present on the site. As per the measurement made on the field, the total land proposed to be required for entry and exit path of the fuel station is 0.00975 ha.

There is no rare/endangered/unique species of flora and fauna found in the proposed area. Neither any archaeological/heritage site / defense establishment is present near the proposed outlet. There is no National Park/ Wildlife Sanctuary situated in and around the proposed site.

On the date of inspection, it was found that no work in violation of the Forest Conservation Act, 1960 has been carried out. The proposed forest area for diversion is the barest minimum and necessary for the development of transport sector.
