The Forest comes under Open Forest Category. The major species found in the proposed project area are Mangifera indica, Madhuca indica, Diospyros melanoxylon, Terminalia tomentosa, Cassia siamea, Tectona grandis, Madhuca latifolia, Zizyphus jujube, Tamarindus indica, Ailanthus excels, Anacardium occidentale, Lagerstroemia parviflora etc.
