RECOMMENDATION OF THE CHIEF CONSERVATOR OF FORESTS, HILL CIRCLE, WEST BENGAL IN CONNECTION WITH THE PROPOSAL FOR DIVERSION OF 0.0144 Ha. FOREST LAND UNDER THE JURISDICTION OF KURSEONG FOREST DIVISION INSTALLATION OF MOBILE TOWER IN FAVOUR OF RELIANCE JIO INFOCOMM LTD.

Reliance Jio Infocomm Ltd. has proposed the land diversion proposal over 0.0144 Ha. Dhobijhora Block of Dowhill Beat within the territorial jurisdiction of Kurseong Range under Kurseong Division, is a bare minimum for the purpose of installation of Mobile Tower.

The proposal for land diversion of 0.0144 Ha. of forest area is recommended for acceptance, for the expansion of communication facilities from strategic point of view, in the public interest.

Yes, on 05.08.2022. The proposed area over 0.0144 Ha. falls Dhobijhora Block of Dowhill Beat within the territorial jurisdiction of Kurseong Range under Kurseong Division. There is no issue of felling of trees for the proposed site and it does not fall under any designated wildlife habitat. It is the barest minimum for the purpose. The proposed area if diverted for the purpose mentioned, would cause minimum interference to the wildlife habitat and movement of wildlife.
