On the subject noted above site inspection has been conducted with user agency and DFO yamunanagar on dated 12-02-2021 as per site inspection and DFO letter no. 2738 dated 12-02-2021 reply of the following objection given are as under –

No.1. As prior proposal submitted by user agency both right and left side included in the case according to that following forest land and trees/plants will be affected

As per new revised proposal by user agency works will be carried out on only left side of the WJC instead of both side is proposed as per revised proposal following forest land and plants will be affected :

As per old proposal user agency mostly included right side (19.18 Hec.) area but as per revised proposal instead of both side only right side is included in the proposal, as per old proposal some patches was left that is now included and service lane is also included in the revised proposal so the area as per new proposal is increased.

As per no. of trees become less it is clarified that according to old proposal the affected trees were on right side is 11076 and on right side of WJC canal 1165 trees of WJC was on inner side slope that is felled by HFDC yamunanagar as per PCCF letter no. C-XI-64/288 dated 07-08-2020. According to this, in right side $11875 + 1165 = 13040$ trees out of which 1165 trees was felled. So as per old proposal and revised proposal the no. of trees in right side is increased not decreased.

No. 2. As per CA scheme submitted by DFO Hisar no. of trees/plants affected will be rectified and revised CA scheme is uploaded on online portal in additional information .
