A Proposal has been received by this Diversion of 0.4752 Ha. of Forest Land for laying 400mm i/d RCC pipeline from Sirsa Distributory to existing Water Works at Village Mochiwala, under Forest Division and Distt. Sirsa, Haryana. The site inspection of the land involved in the proposal been done by me on dated 15-07-2021 along with Division Sirsa.

- 1 On inspection of the site, it is found that the land required by the user agency is a forest area Measuring **0.4752 ha.** The project involving Diversion of Forest land for laying 400mm i/d RCC pipeline from Sirsa Distributory to existing Water Works at Village Mochiwala, under Forest Division and Distt. Sirsa.


