The project has been initiated by the Executive Engineer, National Highway Division, Nashik for diversion of 3.90 ha. Reserve Forest land for Rehabilitation and Up-gradation of the newly declared Jamkhed to Sautada National Highway 548-D (Km 195.375 to Km 208.774) under section 2 of the Forest Conservation Act, 1980 at village Moha Survey no.122 of Gut no. 106 in Taluka Jamkhed, District Ahmednagar in the State of Maharashtra. Deputy Conservator of Forest, Ahmednagar has submitted the proposal with relevant documents to this office as per above reference. 3.3 The total non-forest area involved in the project is 1.074 ha. The site inspection report of the Deputy Conservator of Forests, Ahmednagar Forest Division Ahmednagar is enclosed in the proposal

file on page no.35. Project Note submitted by the Project Authority is enclosed in the file on page no.12.

3.4 The User Agency has given justification for locating the project in forest land that Ministry of Road Transport and Highways, Government of India had decided to develop various National Highways/States Highways & Corridors, where the intensity of traffic has increased significantly and there is a requirement of augmentation of capacity for safe and efficient movement of traffic. So they have decided to take necessary permission under the provision of the Forest (Conservation) Act, 1980. Hence this proposal is submitted by the for necessary clearance.

3.5 The Deputy Conservator of Forest, Ahmednagar has recommended the proposal for diversion of 3.90 ha. of forest land.

A) The Deputy Conservator of Forest, Ahmednagar Forest Division Ahmednagar has certified that:-

- 1) No suitable alternate land is available and the forest land required is minimum, certificate attached on page no.21
- 2) There is no violation of Forest Conservation Act, 1980 or its guidelines, Certificate attached on page no.22
- 3) Proposed Compensatory Afforestation over 8.00 ha. degraded forest land in Gut no.87 at Village Nahuli, Taluka Jamkhed, Dist. Ahmednagar and it is contiguous, suitable for afforestation and management purpose and also it is free from encroachment and an encumbrances and Certificate attached on page no.23
- 4) The non-forest area covered under the project is not under the provision of Maharashtra Private Forest (Acquisition) Act, 1975 by virtue of application of section 35 of the Indian Forest Act 1927 and are not recognized as deemed Reserved Forests as well as not included in the area identified as "Forest" as per dictionary meaning of Forests as mentioned to the expert committee appointed under interim judgment of the Hon'ble Supreme Court dated 12-12-1996., Certificate attached on page no.26
- 5) Proposed project is not likely to affect any monumental site of cultural, historical, religious, archaeological or recreational importance, Certificate attached on page no.27
- 6) The area involved in the project does not form part of any existing National Park, Wildlife Sanctuary, Nature Reserve etc., Certificate attached on page no.28
- 7) The area belongs to Eco-value class-III having density is below 0.01 (Open forest), the amount of Net Present Value of 3.90 ha. forest land is Rs.37,35,342/- and Certificate attached on page no.67
- 8) There are 257 trees involved in the Project.
