13. Specific recommendations of the Deputy Conservator of Forests for acceptance or otherwise of the proposal with reasons.

In 51<sup>th</sup> meeting of the Standing Committee of National Board for Wildlife has recommended the Construction of Nature and Wildlife Awareness Centre at the proposed lands. This project is recommended with the following conditions:-

1. No labour camp shall be established on the forest land at the time of construction.
2. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost.
3. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project.
4. The User Agency shall pay NPV and cost of Compensatory Afforestation per the direction of Hon'ble Supreme Court and Guideline, issued in this regard by MoEF & CC.
