INSPECTION NOTE ON DIVERSION OF 3.04 HA FOREST LAND FOR CONSTRUCTION OF 2 LANNING ARROWA TO TIDDING ROAD FROM KM 0.00 TO 1.76 IN LOHIT DIST OF ARUNACHAL PRADESH BY NHIDCL)

Undersigned along with Sri Lod Lalyang, FR, Range Forest Officer, Tezu Forest Range, Ashirwad Patra, representative of NHIDCL visited the site on **26.09.2022**

It was confirmed by the Range Forest Officer, Tezu that the entire proposed alignment passes through the Proposed Delai Reserved Forests. The existing road also passes through Proposed the Delai RF.

The existing road covers a distance of 1.76 Kms from Arrowa to Tidding is in hilly terrain. This road is only feeder road for movement of defense personals and their equipments from the Brigade Har at Lohitpur to the Indo – China Border in addition to only connectivity of the people of Anjaw District with nearby districts of Lohit & Namsai in particular and rest of India in general.

Mucks likely to be produced during construction works of the road is proposed to be disposed off in designated site identified as per proposal. The Muck disposal site proposed in the proposal has been physically verified by the team and found suitable for muck disposal.

The area identified for the construction of the road passes through the areas having open type of forest and the proposed construction area has under stock vegetation. The area for construction of road and Muck disposal site are not vulnerable to erosion as it is in the foothills.

The area is not important from wild life point of view since no significant species of fauna is available in the area except few species of avi – fauna. No archeological or religious sites exist in the area.

The site identified for raising compensatory afforestation has also been physically verified by the team. The CA site is in one compact patch of 6.08 Ha in Tezu PRF. It has been found suitable for raising plantation and is free from any encumbrances.

A total 14 nos of trees of girth 122 cms and above are likely to be affected. However emphasis would be given to fell barest minimum requirements.

It is recommended to allow the diversion proposal for construction of the road.

Hects of forest land for construction of 2 Lanning of Arrowa - Tidding Road NH - 113 from Km 0.00 to 1.76 Km on EPC Mode in Lohit District of Arunachal Pradesh by NHIDCL (proponent). Project As per physical verification of the requirement of forest land as proposed by the User Agency in Col. 2 of Part - I is unavoidable and barest minimum for the project. The proposed alignment passes through lesser terrain with minimum no of culverts/bridges and shorter in length. An area of 2.28 Ha has already been diverted vide No. FOR. 3 -118/Cons/2010/6005 - 09 Dated 21.08.2014 (Annexure - IX). This proposal is for additional requirement of forest land. The impact on forest and environment will be much less.
