The other alignment passes through hilly terrain which will require more earth cutting and a longer route. The proposed alignment passes through lesser terrain with minimum nos of Culverts/Bridges and shorter in length. Due to less vegetative cover, impact on forest and environment is much lesser. Hence it may be approved.
