

***Recommendation of the Additional Principal Chief Conservator of Forests, Madurai Circle, Madurai regarding diversion of 0.022 Ha of forest land in Valkaradu RF and Parmasivan Koilkaradu RL for laying of underground Optical Fiber Cable (OFC) in Theni Forest Division of Madurai Circle.***

The forest area requested for laying of underground Optical Fiber Cable (OFC) is located in Valkaradu RF and Parmasivan Koilkaradu RL in Theni Range of Theni forest division.

The underground Optical Fiber Cable (OFC) has proposed to be laid 0.373 km in Valkaradu RF and 0.365 km in Paramasivan Koilkaradu RL . There is no felling of trees involved in this proposal and the location is not fall within the Eco Sensitive Zone of Megamalai Wildlife Sanctuary and Kodaikanal Wildlife Sanctuary and Tiger corridors of Mathikettan Shola National park and Pambadum Shola National park of Kerala State.

This project is essential for the development of communication infrastructure of the said area and hence the diversion of forest land to an extent of 0.022 ha may be recommended.
