

**SITE INSPECTION NOTE OF SRI M. RAVI PRASAD, SFS.,
DISTRICT FOREST OFFICER, PEDDAPALLY.**


Inspected the Reserve Forest area proposed for diversion of forest land an extent of 0.4841 Ha, during the inspection by me on 04.11.2019 for "Diversion of forest land it is calculated to an extent of 0.4707 ha in Proposed areas of Peddapally Division for laying of Optical Fiber Cable line which is to be passing through edge of the road burm (Manthani to Kataram) R&B road boundary. The proposed diversion land is falling in Shivaram Crocodile Wildlife sanctuary Core & Buffer zone in Manthani Range and HKR Road ways road boundary from Kesoram Cement Factory gate to IOC Depot at Kundanpally. The proposed diversion land is falling in Forest land in Peddapally Range of Peddapally District. The proposed line is length 11766.93 Rmt, Width of 0.40 mts and depth of 1.20 Mts. The details of area proposed is as follows for diversion:

It is submitted that there is no trees felling in the proposed area. The proposed forest area for diversion is having the density of vegetation is 0.4 to 0.5.

The said proposed area for diversion is falling in Shivaram Crocodile Wildlife Sanctuary (Core & Buffer zone) in Manthani Range and forest land in Peddapally Range and there are no protected Archaeological / Heritage site / defence establishment or any other important monuments. The requirement of forest land as proposed by the user agency in col.2 of Part-I is noticed unavoidable and barest minimum for the project, During filed inspection it is further noticed that, the area proposed for diversion is 0.4707 Ha out of which 0.304 Ha area is falling in Shivaram Crocodile Wildlife Sanctuary (Core & Buffer zone) and 0.1667 Ha area is falling Reserve Forest land area.

The general flora adjacent forest to the road is dry deciduous forest consisting with Nallamaddi, Teak, Thirman, Kodisha, Pala, Palakodisha and Chennangi etc., and the soil type is mixed with red soil. There may not be any effect on flora & founa by permitting the OFC line along the road burm.
