The areas proposed to be diverted are demarcated on the ground. The terrain is plain to gently slope. The soils are generally gravel and hard.

The existing forest is Tropical dry deciduous Forest of 0.10 densities. Since, the proposed diversion of Forest lands are for linear project, the soil erosion is negligible.

There is no rare/endangered/unique species of flora and fauna in the area proposed for diversion. There is no protected archaeological heritage site/defense establishment or any other important monument is located in the area. The area does not form part of National park, Wildlife sanctuary, Bio sphere reserve, Tiger Reserve, Elephant corridor, etc.

The areas required by the user agency are unavoidable and barest minimum for the project. No work in violation of Forest Conservation Act is taken place. If the proposed forest lands are diverted, the impact on the adjoining reserve forests is negligible.
