### INSPECTION REPORT

The proposed alignment for construction of Urban Extension Road-II NH-344M from Design Km 0+000 at NH-1 Intersection (Km 23+800, near Bankoli village) to Design Km 38+111 near Sector 24, Dwarka in the state of NCT Delhi was inspected along with the Dy. Conservator of Forests (West), Dy. Conservator of Forests (North) and the representatives of User Agency on 13.08.2021, Friday.

The User Agency has provided 57.74 Ha. Non Forest Land at the following locations for undertaking Compensatory Afforestation:

- Adjoining NH-24A Eastern Bank of River Yamuna- 2Ha.
- Narela Sub City, Sector G3 & G4, Holambi Kalan, Village Sanoth- 50.74 Ha. (out of this an area of 3 Ha. will not be used for plantation as it comprises transmission line, standing trees and built up area within the plot).
- Dichaon Kalan- 5 Ha.

The sites proposed for Compensatory Afforestation have also been inspected on 13.08.2021, Friday along with DCF (West), DCF (North) and NHAI officials and found suitable for undertaking Plantation.

The said construction is site specific and will lead to decongestion of traffic.
