The Sub Divisonal Officer, Pune (SDO) has passed the restoration of land admeasuiring 3.82 hectare omn 20/11/2001 for Gat No 153 and 19/07/2002 for Gat 154. Recently, vide order no KRA.LAND/KAVI/727/2023 for Gat no 153 and KRA.LAND/KAVI/726/2023 for Gat no 154 dated 17/05/2023, The restoration after 1980 requires approval of the central Govt.

The user agency has submitted the proposal for the diversion of the said land for the purpose of non forest use under section 2 of Forest (Conservation)
