

# **SITE INSPECTION REPORT FOR CONSTRUCTION OF 400 KV DC BONGAIGAON NANGALBIBRA TRANSMISSION LINE BY DIVERTING 31.588 HA OF DEEMED FOREST LAND.**

The NANGALBIBRA-BONGAIGAON TRANSMISSION LIMITED has proposed for Construction of 400 KV DC Bongaigaon Nangalbibra Transmission Line through Deemed Forests of North Garo Hills and East Garo Hills, Meghalaya in 18(Eighteen) Patches under 5 (Five) Villages -

1. Motcholpara Village, North Garo Hills - 8.71 Ha
2. Daranchi Village, North Garo Hills - 7.44 Ha
3. Champe Apal Village, East Garo Hills - 2.36 Ha
4. Napak Nagkama Village, East Garo Hills - 1.82 Ha
5. Dobu Anchengbok Village, East Garo Hills - 11.258 Ha

The Right of Way for the 400 KV DC line is fixed at 46 Metres as per the Chapter 10 of the Handbook on FCA Guidelines issued vide letter F.No. 5-2/2017-FC dated 28.03.2019.

## **Motcholpara Village, North Garo Hills**

1893 metre of Transmission line passes through the deemed forest lands of Motcholpara Village, North Garo Hills in 4 (four) patches, diverting 8.71 Ha of Forest land.

## **Daranchi Village, North Garo Hills**

1617 metre of Transmission line passes through the deemed forest lands of Daranchi Village, North Garo Hills in 4 (four) patches, diverting 7.44 Ha of Forest land.

## **Champe Apal Village, East Garo Hills**

513 metre of Transmission line passes through the deemed forest land of Champe Apal Village, East Garo Hills in 2 (two) patches, diverting 2.36 Ha of Forest land.

## **Napak Nagkama Village, East Garo Hills**

396 metre of Transmission line passes through the deemed forest land of Napak Nagkama Village, East Garo Hills in 1 (one) patch, diverting 1.82 Ha of Forest land.


## **Dobu Anchengbok Village, East Garo Hills**

2447 metre of Transmission line passes through the deemed forest land of Dobu Anchengbok Village, East Garo Hills in 7 (seven) patches, diverting 11.258 Ha of Forest land.



The Proposed Transmission Line does not pass through any of the Notified Reserve Forests and Notified Community Reserves and Total distance of 6867 Metres of 400 KV DC cable passes through the Deemed forests of North & East Garo Hills districts and diverting 31.588 Ha of forest land. The proposed transmission line will result in felling of 4,806 Nos of Trees and 46,440 Nos of Bamboo culms from the 31.588 Ha of deemed forest land.
