In view of this the project is recommended strictly subject to the following conditions being carried out by the User Agency in order to create awareness on environment nature.
			1. Erection of awareness / publicity boards in the area connection with environment & nature. 50 Nos of boards are to be erected by the user agency. The design & specifications of which will be provided by the Forest Department and the cost of design erection, installation, transport etc., will be borne by the User Agency.



2. In order to create more awareness on nature the user agency will setup 2 environment learning & interpretation centre, one in Manthani Range and one in Bhupalpally (East) Range. The design, specifications & estimates of which will be previded by the Forest Department at the time of compliance and the cost of construction & all other costs are to be borne by the User Agency.
