With reference to the above and as per the directions issued by the Additional Principal Chief Conservator of Forests [Forest Conservation] , Bengaluru vide their e-mail cited at reference [1] above, I have instructed the Range Forest Officer, Davanagere on 04-02-2019 to conduct the spot inspection of the above proposed area and submit his detailed report.

Accordingly, the Range Forest Officer, Davanagere and Assistant Conservator of Forests and Technical Assistants to Deputy Conservator of Forests, Davanagere have submitted their spot inspection report to this office vide reference [2] & [3] above respectively. As per their report the proposed area for widening of NH-48 is comes

under Sec-4 area of Sy.No. 130, 131, 132 of Anagodu village and Sy.No. 43, 44 and 45 of Hulupinakatte Village of deemed forest land. Copies of the spot inspection report is enclosed herewith.

Besides, the undersigned is also inspected the proposed area along with Assistant Conservator of Forests and Technical Assistants to Deputy Conservator of Forests, Davanagere and Range Forest Officer, Davanagere Range, Davanagere on 12-04-2019, while agreeing with the reports submitted by the Range Forest Officer, Davanagere. The proforma of Form-A, Part-II of the proposal is filled-up with relevant information and requirement of the area for the above purpose.


