In light of the directions issued by your goodself having forwarded the online proposal under reference (2) cited above to the Deputy Conservators of Forests, Davanagere, and Chitradurga for processing the same, after scrutinizing the online proposal received from the above user agency. Further, as recommended by the Deputy Conservator of Forests, Davanagere, in his letters 19-09-2020 and 22-09-2020, this office had already recommended for diversion of forest land over an extent of 0.789 ha in Anagodu section-4 area Davanagere district, for Bharamasagara LIS, construction of raising main pipeline [CH-36,225 to 37.55 KM] in favour of the Executive Engineer, Karnataka Neeravari Nigama Ltd., Bhadra Canal Division, Davanagere, vide this office letter (3) cited above.

Since, this instant proposal where diversion of forest land involved is falling in both Davanagere and Chitradurga respective divisions, the Deputy Conservator of Forests, Chitradurga Division, Chitradurga in his letter (4) cited above has submitted the report to the effect that no land is falling under the category of the forest land in the jurisdiction of Chitradurga forest division and it also made it clear that it does not fall under the Eco-Sensitive Zone of Jogimatti Wildlife Sanctuary

In view of the facts as detailed above and while agreeing with the self contained report of the Deputy Conservator of Forests, Chitradurga and having confirmed that the proposed drinking water pipeline is not passing through the forest land of Chitradurga Division, hence the proposal for diversion of forest land over an extent of 0.789 ha in Anagodu section-4 area Davanagere district, for Bharamasagara LIS, construction of raising main pipeline [CH-36.225 to 37.55 KM] in favour of the Executive Engineer. Karnataka Neeravari Nigama Ltd., Bhadra Canal Division, Davanagere, may be considered as per the provisions of the Forest (Conservation) Act, 1980. However, the 2 sets of report and documents(maps) received from the Deputy Conservator of Forests. Chitradurga Division, Chitradurga are enclosed herewith for your kind perusal and further needful action in the matter.
