

SITE INSPECTION REPORT

I along with Assistant Conservator of Forests, Ankola Sub-division, Ankola, Range Forest Officer, Ankola, Mastikatta, Ramanguli and Range field staff inspected the proposed diversion of 1.53939 ha. of forest land for diversion of laying underground optical fiber cable along the Right of Way of road in Alagei road-188, Bogribail road-XX, Navagadde 36, 37, 26, 11, 18, XX road, Nala 37, Adlur-road, Nala, Agasoor road-240, Kavalalli Road, Hebbul Raod, Sunksal-162, 97, 96, XX, Road, Kodlagadde-36, Road-16, Nala, Kodsani Bl.XX, Shirur-169A1A1, 169A1B, 190B, 192, 2, 10, 10A, Belse-66, Road-78, Bl.No. XX, 171, Nala-169, 152A1, Bole-Road, Vandige-Road, Sagadgeri-388.

Out of 1.53939 ha. only 1.13136 ha falls in forest area proposed forest land area in Fs y No:26 -Kodsani, 169A1A1, 164A1A1- Shirur, 152A1A1A, 319A1A1A1A1A1A-Belase, 81A1A1, 71A1A1A-Bole, 108-Shedgeri, 188 (Block No:461)- Algeri, 50A1A1(Block No:79A1)- Bogribail, 25 (Block No: 37), 26 (Block No:38)-Navagadde, 23-Adlur, 118A, 63, 33A1, 54A-Agasur,3-Kavalalli, 74, 25-Hebbul, 161, 165, 1-Sunksal, 31, 36A, 21-Kodlagadde, Ankola, Mastikatta and Ramanguli Range, Karwar Division in favour of Deputy General Manager, JIO Digital Fiber Private Limited, No.51, RMZ Icon, Place Cross Road, Vasanth Nagar, Bengaluru. The following observations were made during the site inspection:-

- 1) As per site inspection out of 1.53939 ha only 1.13136 ha. area falls in forest land.
- 2) The area is having comes under Eco-class-I.
- 4) The proposed area is not having any tree growth.
- 5) There are no endangered/ unique-species of flora and fauna found in the area.
- 6) Protected archaeological/heritage site and other important monuments are not located at the proposed site
- 7) The requirement of the forest land as proposed by the user agency is unavoidable and barest minimum.

Hence after considering above observations, I recommend for the diversion of 1.13136 ha. of forest land instead of 1.5393 ha. forest land in Ankola, Mastikatta and Ramanguli Range, Karwar Division in favour of Deputy General Manager, JIO Digital Fiber Private Limited, No.51, RMZ Icon, Place Cross Road, Vasanth Nagar, Bengaluru as per provision of Forest (Conservation) Act, 1980.
