**SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

5.1 A proposal has been received by this office from E.E.C.D.P.W.D. BAIRAD for diversion under FCA-1980) of 0.990 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of Syumbi - Aamkulau Motor Road in Birukhal Block. The site inspection of the land involved in the proposal has been done by me on dated 15.12.2019

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 0.990 ha. (Reserve Forest = 0.70 ha. Civil = 0.18 ha. Vanlamchayal = 0.81 ha.)

5.3 The requirement of forest land as proposed by the user agency in Col.2 part-1 is unavoidable and is barest minimum required for the project. yes.
