

SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

(For the Forest land to be diverted under FCA)

A proposal has been received from M/s. Hindalco Industries Limited, Renukoot, Sonebhadra for renewal under (FCA-1980) of 6.394 ha. Forest land for construction of 132 KV. Transmission Line between Rihand Power Station to Hindalco Plant, Renukoot in Pipri Forest Range of Renukoot Forest Division. The Proposed land was transferred on lease to M/s Hindalco Industries Limited, Renukoot vide State Govt. G.O. 4887(2)/14-2-794/72 Dated 2-9-72 for 25 years (1.04.1972 to 31.03.1997) and the same was renewed for next 25 years (1.04.1972 to 31.03.2022) vide Central Government G.O. No. 8B/04/ 2074/2000 FC/ 726 dated 06.10.2000 and State Govt. G.O. No. 774/14-2-2000-749/72 dated 02.03.2001. The said lease is required to be renewed for further 25 years (1.04.2022 to 31.03.2047). The site inspection of the land involved in the proposal has done by me on dated... 15-12-2021

On inspection of the site, it is found that the land required by the user agency in a Reserved Forest measuring 6.394 ha.

The requirement of forest land as proposed by the user agency in col-2 Part-I is unavoidable and is barest minimum required for the project.
