
**15. Specific recommendation of the DFO for acceptance or otherwise of the proposal with reason:**

The proposed diversion for the forest land for the construction/installation of 11kv transmission line is necessary due to upcoming construction of a via-duct by the National Highways & Infrastructure Development Corporation Ltd. because of which the existing feeders need to be shifted.



The proposal requires diversion of 0.0074 ha. of forest land which is unavoidable and barest minimum.

Therefore, the diversion of forest land is recommended for approval subject to conditions laid by the State and/or Central Government.
