- 5.1 A proposal has been received by this office from Executive Engineer construction Division P.W.D.Nainital for diversion under FCA-1980) of 0.936 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of approach road from Nawali feom km-11 of Laxmikhan-Nathhuwakhan- Pura-Qurab motor road to Losgayani in Ramgarl Block The site inspection of the land involved in the proposal has been done by me on dated 12 12-2019
- 5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/unclassed/Other forests measuring 0.936 **ha**. Civil soyam Land.
- 5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मार्ग 5.00 किमी0 लम्बाई तथा 9 मीटर चौडाई में प्रस्तावित किया गया था । जिसमें सिविल एवं सोयम भूमि 1040 मीटर यानि 0.936 हैं0 तथा नाप भूमि 3940 मीटर यानि 3.564 है0 प्रभावित होती थी । उक्त प्रस्तावित मार्ग के समरेखण में सिविल एवं सोयम भूमि में 53 चीड प्रजाति वृक्ष प्रभावित होते हैं तथा नाप भूमि में 82 वृक्ष प्रभावित होते हैं । जिसमें बॉज प्रजाति के वृक्ष प्रभावित नहीं होते हैं । ऑन लाईन 53 वृक्षों की पृविष्ठी की गई हैं जिसमें बॉज प्रजाति के वृक्ष नहीं हैं । नाप भूमि में प्रभावित होने वाले 82 वृक्षों को ऑन लाईन टिप्पणी में अंकित किये गये है । स्थल निरीक्षण के दौरान स्थानीय जनप्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम त्वेशाज्ञानी जिनकी परिवारों की संख्या 165 तथा जनसंख्या 812 हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु संस्तुति कर अग्रसारित किया जाता हैं ।
