Shokinkumar Shankarlal Jain, 30/33, Second Floor, Thakur Arcade, Station Road, Virar (West) – 401 303.

- 2.00 The Project Authority has submitted a proposal for diversion of 14.93 Ha. Restored Area u/s.22-A of Maharashtra Private Forest (Acq.) Act 1975 of Private Forest Survey No. 40 of Village Valiv, Tal. Vasai, Dist. Palghar for Non forest purpose & approval to restoration order dated 26.09.1994 of SDO Bhiwandi. Therefore, the Project Authority is seeking GOI's permission u/s.2 of Forest (Conservation) Act, 1980.
- 3.00 The Restored Forest area required for this Project is 14.93 Ha. The details of the land proposed for diversion are as under:-

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted Necessary Certificates / Undertakings and Maps which are also enclosed in the proposal.
- 5.00 The proposed area i.e.14.93 Ha. from village Valiv of Vasai Taluka falling within 10 kms. of the boundary of the Tungareshwar Wildlife Sanctuary. The Deputy Conservator of Forests, Thane certified that the, said Project will not have any adverse effect on the Wildlife within National Park/Sanctuary.
- 6.00 Diversion of Restored Area u/s.22-A of Maharashtra Private Forest (Acq.) Act 1975 of Private Forest Survey No.40 of Village Valiv, Tal. Vasai, Dist. Palghar for Non forest purpose & approval to restoration order does not included in the area of any National Park / Wildlife Sanctuary or Nature Reserve.
- 7.00 There is no violation of Forest (Conservation) Act, 1980 and its guidelines as certified by the Deputy Conservator of Forests, Thane. However, in the year of 1974 a construction of Ice factory has been established over 0.36 ha. out of total 14.93 ha. with all requisite permissions i.e. after enactment of FCA 1980.
- 8.00 The User Agency had applied for the FRA 2006 certificate from Collector Palghar.
 Regarding to this, the necessary undertaking is submitted and the same is enclosed in the proposal by Project Authority. The Project Authority may be asked to submit FRA certificate before recommending the proposal to Government.
- 9.00 There is 735 trees requires to be felled for implementation of the project. The list of trees and estimate of felling is enclosed in the proposal.
- 10.00 The proposal involves 14.93 ha. Private forest land. Therefore, the Project Authority has proposed 15.98 ha. Compensatory Non-Forest land in Gut No.875/2 at Village Furus, Tal. Chiplun, Dist. Ratnagiri. The said land has been inspected by Divisional Forest Officer, Chiplun and certified that 15.58 ha. non forest land proposed for alternative Compensatory Afforestation is contiguous & suitable for Management purpose and it is free from encroachment and encumbrances.
