The proposal was verified by the Range Forest Officer, Pavagada and Assistant Conservator of Forests Madhugiri Sub-division, Madhugiri along with staff and submitted a detailed report to this office for taking further needfull action.

The proposed unit of land measuring 0.308 ha falls in Sy. No. 8 of Thimmalapura village & Sy. No. 1 of Nidgal village, Pavagada Taluk, Nidgal Reserve Forest.

The proposal was already verified by me on dated 21-07-2021. The said forest area falls under Eco Class-III with Central Dry Zone Deciduous type of Forests. The proposed are consist of trees like Acasia Nilotica (Jalli), Stereospermum chelonoides (udaya), Albizia amara (Tuggali), Cassia siamea (Seeme Thangadi), Cassia fistula (Kakke), Wrightia tinctoria (Marale) and other species.

There are 68 trees in the area which is sought for diversion. The user agency has agreed to pay the cost of raising compensatory afforestation, net present value, lease rent as per the prevailing rates.

In view of the above facts and circumstances, The proposal for diversion of forest land is barest minimum and unavoidable, I recommend an extent of 0.732 ha forest land in Sy. No. 8 of Thimmalapura village & Sy. No. 1 of Nidgal village, Pavagada Taluk, Nidgal Reserve Forest Tumakuru District. Which is required for Drinking water supply scheme to Rural Habitations and Town of Pavagada Taluk under Sec-2 of Forest (Conservation) Act-1980.

Spot inspection by the under signed was conducted on 17-06-2022. The proposal is for Diversion of Forest Land an extent of 8.49 ha for Drinking water supply scheme to Rural Habitations and Town of Pavagada Taluk in Tumakuru District, Karnataka State, India-reg under Sec-2 of Forest (Conservation) Act-1980.
