Fulfillment of condition (ii) & (ix) has not yet them complied by the applicant (WCL). Rs.25,54,62,766/- has not yet been deposited by the user agency (applicant WCL) till date. The amount to be deposited by applicant was due in 2012. During the last 5 years this amount has increased due to price escalation. 4- The applicant agency is continuously extracting mineral from the above mentioned forest land since 1980, therefore Ex-post facto approval may be granted to the applicant after imposing penalty on the organization as mining activities is being carried out by the organization without prior approval of the Central Government.
