The project authority has not started the non-forestry work on Forest Land. The project authority is willing to bear the cost of felling of trees. In this project compensatory afforestation scheme is proposed on non-forest land in Roha Forest Division at village Karivane, S. No. 21/2 area 12.500 ha. and at village Temphar S.No. 57/1 area 10.049 ha. total area is 22.549 ha.

This project is a part of New Mumbai International Airport project. Therefore this project is important for infrastructure development and is of national interest and importance; hence the proposal is being submitted for approval for diverting the required forest land under Forest (Conservation) Act, 1980 on the following conditions-

- The area diverted will be used only for purpose mentioned in proposal.
- 2) Cost of compensatory afforestation to be borne by the Project Authority.
- 3) Net Present Value to be borne by Project Authority.
- 4) The adjoining forest land along patch No. 1,2,3 & 4 and two survey nos. 124 and 128 landlocked by project area, needs to be protected against encroachment by construction compound wall at the cost of project authority.
- 5) Project Authority has to provide residential quarters and office space for Uran Range office, at their own cost.
- 6) 10 Fire blower machines and 10 grass cutter machines are required for fire protection purpose of surrounding forest area.
