Hence this project would result in substantial financial and social benefits and substantial saving in terms of vehicle operating costs, travel cost, reduce traffic congestion, reduce accidents etc. Hence this project proposal is recommended for consideration and onward transmission for necessary approval under section 2 of Forest (Conservation) Act 1980 subject to the following conditions. (a) The wild animals particularly elephants cross the NH from Duburi to Botalanda at various points during their movement for which, opinion of Chief Wildlife Warden, Odisha may be obtained before considering the proposal for approval. (b) All the Govt. vehicles of Forest Deptt. may be exempted from payment of toll tax at the toll gates over any NH in the State of Odisha.
