

**Construction of 132KV D/C Hunterganj-Chatra Transmission Line under NIT  
No. 309 (Length- 19.7085Km)**

**SITE INSPECTION REPORT OF DIVISIONAL FOREST OFFICER, CHATRA NORTH FOREST DIVISION**

---

The proposed Construction of 132KV D/C Hunterganj-Chatra Transmission Line under NIT No. 309 (Length- 19.7085Km), Chatra North Forest Division was inspected on 20.02.2021. The Manager, JUSNL, Chatra along with subordinate staffs, and RFO, Hunterganj were present in the site inspection.

In Chatra North Forest Division, 132KV D/C Transmission Line (Hunterganj-Chatra) passes through Seventeen villages having Protected Forest (PF) Bonra, Kangurua, Karma, Bhoktadih, Kathoun, Basariya, Gobardih, Kon, Tetaria, Sildaha, Bedouli, Kanchan, Mungwadaha, Bakain, Karailibar, Kurid, and Bakhardih. From Barisaram to Mohnadih part of this Transmission Line in Chatra South Forest Division. During this inspection it was observed that the forest land required for this project falls partly in plantation of 2006-07 having density 0.6 and some pathces of moderate dense forest with shrubs cover along with sporadic patches of eroded rocky areas. Naturally growth of Butea monosperma, Mallotus philippensis, Acacia catachu, Phoenix Spp., Cassia siamea were observed all along forest area and plantation area.


On inspection of the site, it is found that land required by the User Agency is a Protected Forest (PF) land measuring **23.3355ha. (Forest Land-13.5740ha.+ G.M.J.J- 9.7615ha.)**

The requirement of forest land as proposed by the user agency in Col-2 of Part-I is unavoidable and is barest minimum required for the project.

There is no any rare/endangered/unique species of flora and fauna found in the area.

There is no any protected archaeological / heritage site / defence establishment or any other important monument is located in the area.


