

FIELD INSPECTION NOTE OF SRI. Ch. SIVIAH, S.F.S
DISTRICT FOREST OFFICER, PEDDAPALLY DISTRICT

Inspected the Reserve Forest areas and Shivaram sanctuary areas proposed for diversion of forest land an extent of 1.3522 Ha along with Forest Range Officers, Peddapally and Manthani and also with User Agency on 03.12.2021, during the inspection it is observed that an extent of 1.3522 ha area is passing through edge of the road burn along the existing road boundary. The proposed site passing through Reserve Forests of Banjarpally, Putnur, Rayadandi, Thakkallapally, Kannala, Upperlakesoram, Khammampally, Manthani, Bhatpally and Swarnapally Extn in Manthani and Peddapally Ranges of Peddapally District. The proposed line length is 30049.01 Rmt, Width of 0.45 mts and depth of 1.65 Mts. The terrain is plain to undulating. The proposed area is also passing through Shivaram Crocodile Wildlife Sanctuary, Eco Sensitive Zone and Reserve Forest areas. The details of area proposed is as follows:

There are no protected Archaeological / Heritage site / defence establishment or any other important monuments.

The requirement of forest land as proposed by the user agency in col.2 of Part-I is noticed unavoidable and barest minimum for the project. During filed inspection it is further noticed that, the area proposed for diversion in the area for diversion as per field verification is 1.3522 Ha out of which 0.7866 Ha falling in RF areas in Peddapally and Manthani Ranges, 0.2125 Ha area is falling in Eco Sensitive zone and 0.3531 Ha area is falling in Shivaram Wildlife sanctuary in Manthani Range of Peddapally District.

The general flora adjacent forest to the road is dry deciduous forest consisting with Nallamaddi, Teak, Thirman, Kodisha, Pala, Palakodisha and Chennangi etc., and the soil type is mixed with red soil.
