The Deputy Conservator of Forests, Jawhar has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/FCA/1039, dated 23.11.2022. Mehul Hashmukh Gandhi, 602, A-Wing, Meru Tower, Sir Jamsheth Road, Matunga (East), Mumbai - 400 019.

2. The Project Agency has submitted the Proposal for diversion of 0.18 ha. Protected Forest Land for Construction of Access / Approach Road to proposed Logistic Park along with Ware Houses Project, underground Water Pipeline, Electricity cable & other ancillary Works under old Survey No.98/1, New Gut No.239/4 of Village Kharivali tarfe Paulbar, Tal. Wada, Dist. Palghar in the State of Maharashtra.

Therefore, the Project Authority is seeking Government of India's permission u/s.2 of Forest (Conservation) Act, 1980.

- 4.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted necessary Certificates / Undertakings and Maps, which are also enclosed in the proposal.
- 5.00 The Deputy Conservator of Forests, Jawhar has certified that the Project involves less than 1.00 ha. forest land, therefore the Compensatory Non forest land is not required. Hence, Compensatory Afforestation is proposed on 1.00 ha. degraded forest land. The degraded forest land identified for Compensatory Afforestation from Protected Forest Gut No.25 of Village Kayalu, Tal. Wada, Dist. Palghar and is suitable for afforestation and management purpose also it is free from encroachment and encumbrances.
- 6.00 The Deputy Conservator of Forests Jawhar has certified that the provisions of Forest (Conservation) Act, 1980 and guidelines under it has not been violated in the Project.
- 7.00 The Deputy Conservator of Forests, Jawhar has certified that there is no felling of trees required in the Proposal for diversion of 0.18 ha. Protected Forest Land for Construction of Access / Approach Road to proposed Logistic Park along with Warehouses Project, underground water pipeline ,Electricity cable & other ancillary Works under old Suevey No.98/1,New Gut No.239/4 of Village Kharivali tarf Paulbar, Tal. Wada, Dist. Palghar in the State of Maharashtra.
- 8.00 The Project Authority has given undertaking that certificate under FRA-2006 from Collector Palghar will be submitted after Stage-I approval of the Project.
- 9.00 The Deputy Conservator of Forests, Jawhar has certified the proposed forest area for diversion of 0.18 ha. of Protected Forest land (S. No.98/1), new Gut No.239/4 for Construction of Access / Approach Road to proposed Logistic Park with Ware houses Projects including underground water Pipeline, Electricity cable & other ancillary activities

at Village Kharivali, Tal. Wada, Dist. Palghar is falling outside 10 kms. of Tansa Wild Life Sanctuary. Further certified that the Proposed forest land required for the project is not part of any Eco- sensitive Zone. The proposed area is not included in the area of any National Park, Wildlife Sanctuary or Nature Reserved.

- 10.00 The Deputy Conservator of Forests, Jawhar has certified, that the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.
- 11.00 The Deputy Conservator of Forests, Jawhar has carried out Site Inspection on dated 25.08.2022. The site inspection report is enclosed in the proposal.
- 12.00 The Deputy Conservator of Forests, Jawhar's report is self-explanatory and this office agrees with the same.
- 13.00 This project is for diversion of 0.18 ha. Protected Forest land Gut No.239 (S. No.98/1), New Gut No.239/4 for Construction of Access / Approach Road to proposed Logistic Park, with Ware houses Projects including underground water pipeline, Electricity cable & other ancillary activities at Village Kharivali, Tal. Wada, Dist. Palghar in the State of Maharashtra, which required less than 1.00 of forest land. Project proponent is ready to bear all the Government levies and as per recommendation of the Deputy Conservator of Forests, Alibag the proposal is recommended for acceptance and necessary approval U/s.2 of Forest (Conservation) Act, 1980.
