

FIELD INSPECTION NOTES OF THE DISTRICT FOREST OFFICER, SIDDIPET
IN RESERVE FOREST LAND ON 29 - 07 - 2021.

Today, I along with the Forest Range Officer, Dubbak and their field staff have inspected the Reserve Forest areas proposed for diversion of 0.811 Ha. Forest Land in RF Indupriyal for Construction of Shankarampet Branch canal system (Ramayampet canal) in Siddipet District as detailed below:

The said area is passing through the Indupriyal RF, The canopy of this area is 0.2 to 0.4 and about 12 trees are required to be removed from the said area. the dominant species in this area are 1) Vepa (Azadirachta indica), 2) Nalla Jeedi (Semecarpus anacardium), 3) Soppera (Dalbergia paniculata), 4) Teak (Tectona grandis), 5) Moduga (Butea monosperma), 6) Neelagiri (Eucalyptus globules), 7) Bamboo (Bambusa vulgaris) etc., Enumeration and valuation of the tree growth in proposed area is completed (list enclosed).

I have searched for other alternatives, but there is no alternative land available except the present proposal. This is the barest minimum area that is required for Construction of Shankarampet Branch canal system (Ramayampet canal) in Indupriyal Reserve Forest. No work is started as on date in violation of FC Act 1980. There are no encroachments and also claims in the RF area that attracts the RoFR Act 2006.

1. The area is does not fall in wildlife protected areas, archaeological heritage site, important monument there are no claims pending under RoFR Act.2006.
2. There are no endangered species that are caused or harmed due to Construction of Shankarampet Branch canal system.

Further the proposed CA land 6.5804 Ha. which is in two bits i.e., Bit 1 @ 4.2314 Ha. and Bit 2 @ 2.349 Ha. is located in Sy.No.876 of Koheda (V&M) of Siddipet District was also inspected along with Forest Range officer, Husnabad on 27.07.2021 and it is found that the area is with adequate tree growth and the block plantation can be raised inside the CA Lands with not more than 100 Plants per Ha. Further the SMC works like SCTs have already taken up under MGNREGS through MCC. RFDs can be taken up to an extent of 30 to 40 and Mini PTs up to 5 No.s. As these blocks are isolated, providing boundary protection structures is inevitable.
