- 2.15 Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 2.16 The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 2.17 No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 2.18 The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 2.19The forest land shall not be used for any purpose other than that specified in the project proposal
- 2.20 The forest land proposed to be diverted shall under no circumstance be transferred to any other agencies, department or person without prior approval of Government of India.

- 2.21 Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guidelines F.No.11-42/2017-FC, dated 29/01/2018.
- 2.22 Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- 2.23 The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/)
- 3.0 Keeping in view facts mentioned in above para this proposal for diversion of 0.1500 ha. Reserved Forest (Notified of IFA 1927) land under section-2 of the Forest (Conservation) Act, 1980 for construction of Approach Road to Private land Survey No.12/6, village Vindhane, Tal. Uran, Dist. Raigad in the State of Maharashtra is recommended for approval under Forest (Conservation) Act, 1980.
