DETAILS OF FOREST LAND PROPOSED FOR DIVERSION

The area is stretched in a linear way going more or less parallel to the National Highway-60 closely and the distance from nearest forest boundary is at a range of 10 meters to 170 meters, on an average 45.7 meters. There are 1069 Nos. of different trees of 31cm to 150cm girth (BHG OB) and 14 Nos. of trees below 30 cm girth existed throughout the proposed area. The legal status of the area is protected forest, not vulnerable for soil erosion. There is no any rare, endangered, unique species of flora and fauna are found there. The site does not cover any archaeological, heritage site, defence establishment or any other important monument.
