SITE INSPECTION REPORT- NOT BELOW THE RANK OF DCF

(for the forest land to be diverted under FCA)

5.1 A proposal has been received by this office from **Executive Engineer** construction Division P.W.D.Nainital for diversion under FCA-1980) of 0.936 ha. of forest land for non-forestry purpose. The project envisages the use of forest land for construction of **motor road from Matiyali to Prachin Mandir Kalirothrough km-10 of Mauna -Lweshal-Kalapatal and Prathmik Pathshala in Ramgarh Block** The site inspection of the land involved in the proposal has been done by me on dated 28 - 02-2020

5.2 On inspection of the site, it is found that the land required by the user agency is a RF/PF/un-classed/Other forests measuring 0.900 ha. RF/ Civil soyam Land.

5.3 The requirement of forest land as proposed by the user agency in Co1.2 part-1 is unavoidable and is barest minimum required for the project. **Yes**

उक्त प्रस्तावित मार्ग 3.00 किमी० लम्बाई तथा 9 मीटर चौड़ाई में प्रस्तावित किया गया था । जिसमें आरक्षित वनभूमि 650 मीटर यानि 0.585 है० तथा सिविल एवं सोयम भूमि 350 मीटर यानि 0.3150 है० तथा नाप भूमि 2000 मीटर यानि 1.800 है० प्रभावित होती थी । उक्त प्रस्तावित मार्ग के समरेखण में आरक्षित वन भूमि में 46 वृक्ष तथा सिविल एवं सोयम भूमि में 17 विभिन्न प्रजाति वृक्ष प्रभावित होते हैं तथा नाप भूमि में 17 वृक्ष प्रभावित होते हैं । जिसमें बॉज प्रजाति के वृक्ष प्रभावित नहीं होते हैं । ऑन लाईन 63 वृक्षों की पृविष्ठी की गई है जिसमें बॉज प्रजाति के वृक्ष नहीं हैं । नाप भूमि में प्रभावित होने वाले 17 वृक्षों को ऑन लाईन टिप्पणी में अंकित किये गये हैं । स्थल निरीक्षण के दौरान स्थानीय जनप्रतिनिधियों द्वारा अवगत कराया गया कि उक्त मार्ग के निर्माण से ग्राम ल्वेशाल जिनकी परिवारों की संख्या 76 तथा जनसंख्या 243 हैं लाभान्वित होते हैं । अतः प्रस्ताव को भारत सरकार की स्वीकृति हेतु अग्रसारित किया जाता है ।
