The Deputy Conservator of Forests, Alibag has submitted the proposal mentioned in the subject vide his letter No. A/20/Land/2170, dated 31.03.2018. Photo copy of the same is enclosed herewith for your ready reference. The Project Agency of this project is General Manager (Environment and Forests) CIDCO, CIDCO Bhavan, CBD-Belapur, Navi Mumbai.

- 2.00 General Manager (Environment and Forests) CIDCO, CIDCO Bhavan, CBD-Belapur, Navi Mumbai submitted a proposal for area 22.549 ha. for public utility infrastructure to the Rehabilitation of PAPs of Navi Mumbai International Airport at Pushpak nagar, Village Dapoli, Taluka Alibag.
- 3.00 The Project Authority previously submitted a proposal for diversion of forest land for rehabilitation of PAPs of Navi Mumbai International Airport which is submitted to the Govt. of India for approval by proper channel. In the FAC meeting held on 12.07.2016, it was denied approval in the present from. The same was conveyed by Asstt. Inspector General of Forests, MoEF & CC vide letter No.FC-II/MH-16/2015/NGP, dated 8th August, 2016.
- 4.00 The Project Authority re-planned the area excluding the rehabilitation of the people on the forest land. As per revise plan prepared by the Project Authority the public utility infrastructure is proposed on forest area and submitted this proposal for the diversion of 22.549 ha. forest area.

5.00 The Project Authority has submitted a proposal for public utility infrastructure for the Rehabilitation of PAPs of Navi Mumbai International Airport at Pushpak nagar, Village Dapoli, Taluka Alibag. Therefore, the Project Authority is seeking GOI's permission u/s.2 of Forest (Conservation) Act, 1980.

6.00 The Forest land required for this Project is 22.549 Ha. The details of land proposed for diversion is as under:-

7.00 The area involved in this proposal does not form part of any existing National Park, Wildlife Sanctuary or Nature Reserve.

8.00 Deputy Conservator of Forests, Alibag has certified that, the provisions of Forest (Conservation) Act, 1980 and its guidelines under it have not been violated in project for Diversion of forest land 22.549 ha. for Rehabilitation of PAPs of Navi Mumbai International Airport at Pushpak nagar, Village Dapoli, Tal. Panvel.

9.00 Project involves 22.549 ha. forest land. Hence Compensatory Afforestation on 22.549 ha. Non Forest land is proposed. The Non Forest land identified for Compensatory Afforestation is from Survey No.21/2 Pt. of village Karivane, area 12.500 ha. & Survey No.57/1 at Village Temghar, area 10.049 ha. in Roha Division. The suitability certificate and other related documents of Deputy Conservator of Forests, Roha are attached in the proposal. The Project Authority is willing to bear the cost of Compensatory Afforestation as required by the GOI and also ready to bear the cost of felling of trees.

10.00 The Project Authority has given an undertaking to pay the cost of Net Present Value as directed by the Govt. of India. The Project Authority has submitted Necessary Certificates / Undertakings and Maps which are also enclosed in the proposal.

11.00 The proposed area i.e. 22.549 ha. is within 10 km. radius from the boundary of the Protected area (Sanctuary & National Park). The Deputy Conservator of Forests, Alibag as certified that, the said Project will not have any adverse effect on the Wildlife within National Park / Sanctuary.

- 12.00 The User Agency has fulfilled the compliance under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Right) Act 2006.
- 13.00 The Deputy Conservator of Forests, Alibag has certified, that the proposed Project is not likely to affect any monuments site of culture, historical, religious, archeological or recreational importance.
- 14.00 The Deputy Conservator of Forests, Alibag has certified that, other alternate alignment is not possible and the forest land required is the barest minimum.
- 15.00 The Deputy Conservator of Forests, Alibag has carried out site inspection on 28.03.2018. The site inspection report is enclosed in the proposal.
- 16.00 Report of the Deputy Conservator of Forests, Alibag is self-explanatory and this office agrees with the same.
- 17.00 As per the recommendation of the Deputy Conservator of Forests, Alibag, this project is a part of Navi Mumbai International Airport Project and this project is important for infrastructure development & National interest. The proposal is being recommended.
- 18.00 Five sets of proposals are enclosed herewith, with all required documents for further necessary action. Proposal has already been submitted online vide No. FP/MH/REHAB/12953/2015.
