It is submitted that the Director of Mines and Geology,

Vijayawada, vide reference 1st cited, has forwarded the application of Sri Kunam Brahmananda Reddy, Ongole for diversion of forest land over an extent of 4.96 Ha. of forest land falling in Compt. No.127 of Ameenabad Beat, Perecherla (V), Medikonduru Mandal, Guntur District for grant of quarry lease for Road Metal and Building Stone.

While forwarding the application, the DMG, Vijayawada has furnished the following information:

- The proposed area is situated about 2 Kms. South of Perecherla (V), Medikonduru (M) of Guntur District and it can be located by cart track from Perecherla Road about 1 1/2 KM distance and taking left diversion at crushing unit held by M/s. Jagadamba Stone Crusher at Perecherla -Narasaraopet road.
- This type of material is not available outside of Reserve Forest. The rock type encountered in Kondaveedu RF area is charnockites with maffic colour hard and compact in nature. There are no areas in the vicinity of Perecherla Zone for grant of leases for excavation of road metal. The available rock is unique in homogeneity, colour and hardness.
- The applied area is a hillock with an elevation of about 18 to 24 Mts. from ground level / falls on South-West slopes of the hillock.
- The applied area is comprising of charnockites belonging to Archean group of rocks. The charnockites available in the area is grey in colour, hard and compact in nature medium grained texture. The charnockites available in the area may not be useful for cutting and polishing due to numerous cracks and joints and it may be useful for railway ballast, road metal, crusher feeding in turn will be useful for building constructions and other civil constructions.
- Other information furnished by the DMG, Vijayawada may be perused in the inspection report furnished in Booklet at Page No.217 to 226.
- With the above information, the DMG, Vijayawada has recommended for diversion of forest land over an extent of 4.96 Ha. in Block No.127, Ameenabad Beat, Kondaveedu RF, Guntur Range, Guntur District for grant of quarry lease for Road Metal and Building Stone in favour of Sri Kunam

Brahmananda Reddy, Ongole, Prakasham District.

Subsequently, vide reference 2nd cited, Sri Kunam Brahmananda Reddy has uploaded proposals in ministry's website for diversion of 4.78 Ha. of forest land in Compt. No. 127 of Kondaveedu RF of Ameenabad Beat, Perecheral (V), Medikondur (M), Guntur for grant of quarry lease for Road Metal & Building Stone in f/o. Sri Kunam Brahmananda Reddy, Ongole, Prakasham District. The proposal is registered with unique No. FP/AP/ORY/37852/2018, Dt.24.12.2018.

Accordingly, the proposals were forwarded to the Divisional Forest Officer, Guntur vide reference 5th cited for processing as per the guidelines of Forest (Conservation) Act, 1980 through the Conservator of Forests, Guntur. Subsequently, Conservator of Forests, Guntur, vide reference 6th cited, has submitted the proposals duly processed under Forest (Conservation) Act, 1980, which are as detailed below.

The user agency has furnished the following information in Part-I:

- The proposal is for diversion of 4.78 Ha. of forest land in Compt. No. 127 of Kondaveedu RF of Ameenabad Beat, Perecheral (V), Medikondur (M), Guntur for grant of quarry lease for Road Metal & Building Stone in f/o. Sri Kunam Brahmananda Reddy, Ongole, Prakasham District.
- For locating the project in forest area, the User Agency has justified that the proposal is submitted for conducting Quarrying operations for Road Metal Over an extent of 4.78 ha. in Compt.No.127 of Kondaveedu RF of Ammenabad Beat, Pereecherla (V), Medikonduru (M), Guntur District. This particular variety of Road Metal is uniquely available in the applied forest area and not available in anywhere outside.
- The user Agency has furnished the DGPS authenticated maps for the area proposed for diversion and CA land.
- · Statement showing the details of forest area involved:

- The User Agency has submitted that there will be no displacement of people due to this project and there is no requirement of Cost-Benefit analysis.
- The User Agency has submitted the certificate under RoFR Act, 2006, as required under F (C) Act, 1980.
- The User Agency has certified that they have applied to obtain No objection Certificate from Pollution Control Board and soon after its receipt, the same will be submitted.
- The user agency has indicated the safety zone area for the proposed mining in the authenticated DGPS map. May be perused at Page No. 37 of the booklet. However, not furnished the details ascertained from competent authority viz., Indian Bureau of Mines/ Department of Geology & Mining of State Government.
- The User Agency has submitted undertakings to bear the cost of raising and maintenance of compensatory afforestation in identified CA land, payment of N.P.V., additional N.P.V., cost of fencing and regeneration of safety zone area cost of afforestation over one and half time of the safety zone area in degraded forest elsewhere, as and when the demand is raised by the Forest Department, if any.
- The user agency has identified non forest land for compensatory afforestation over an extent of 5.22 Ha. in Allinagaram (V), Komarole (M), Giddalur Range, Giddalur Division.
- The User Agency has submitted that the employment likely to be generated due to this project is 20 number of persons (Permanent) and 100 number of person-days (Temporary).
- The User Agency has certified that there is no violation occurred under provisions of Forest (Conservation) Act, 1980.
- Details of DGPS equipment used and agency / person involved in the survey are not provided.

The Divisional Forest Officer, Guntur has furnished the information in part-II as follows:

- The Divisional Forest Officer has submitted an abstract on Enumeration of Tree growth and mentioned 212 nos. of trees are to be felled in the proposed area.
- The Divisional Forest Officer has inspected the forest area involved in the project proposal on 17.04.2019. Site Inspection report of Divisional Forest Officer along with photographs is enclosed.
- The Divisional Forest Officer has stated that the Flora (Grewia tiliifolia, Prosophis juliflora, Brassica oleracea var. sabellica, Dichrostachy scinrrea, Azardaricta indica and Fauna (Wild Boar & Hare) are available in the Reserve Forest and certified that there is no impact on the flora & fauna in the adjoining forests due to this proposal.
- The Divisional Forest Officer has stated that the alignment is gentle gradient and hence certified that there is no impact on the ecology, especially on soil erosion in and around the proposed area due to this project.
- The Divisional Forest Officer has certified that there are no rare / endangered / unique species of flora and fauna found in and around the proposed area and hence stated that it is not necessary to take up mitigative measures to prevent loss of flora, fauna & soil erosion.
- The Divisional Forest Officer, Guntur has stated that nonforest area identified over an extent of 5.22 Ha. in Sy.No. 1019 of Allinagaram Village of Komarole Mandal. Prakasham District in lieu of diversion of 4.78 Ha. of forest land in Compt. No. 127 of KondaveeduRF of AmeenabadBeat, Perecheral (V), Medikondur (M), Guntur for grant of quarry lease for Road Metal & Building Stone in f/o. Sri Kunam Brahmananda Reddy, Ongole, Prakasham District.
- The Compensatory Afforestation scheme has been prepared by the Divisional Forest Officer, Giddalur to an extent of 5.22 Ha. with total financial outlay of Rs.78.50 lakhs for the period from 2020-21 to 2031-32.
- The Divisional Forest Officer, Giddalur has stated that the non-forest land identified for CA is an enclosure to Maduva RF in lieu of the subject project.
- The Divisional Forest Officer, Giddalur has certified that the identified non-forest land for Compensatory Afforestation to an extent of 5.22 ha. of forest land in Sy.No.1019 of Alinagaram (V), Kommarole (M) of Prakasham District is

- suitable for raising plantations.
- The Divisional Forest Officer has furnished the following statement showing the calculation of Net Present Value in the proposed area for diversion.

- The Divisional Forest Officer, Guntur has certified that the User Agency has not carried out any work in the proposed area and not violated the provisions of the Forest (conservation) Act, 1980 &Wildlife Act, 1972.
- Area proposed by the User Agency for diversion of 4.78 Ha. of forest land in Compt. No. 127 of Kondaveedu RF of Ameenabad Beat, Perecheral (V), Medikondur (M), Guntur for grant of quarry lease for Road Metal & Building Stone in f/o. Sri Kunam Brahmananda Reddy, Ongole, Prakasham District has been notified under Section 16 of madras Forest Act (ACT V), 1882 Dt.01.02.1895 vide Notification No.Fort. St. George, Dt.23.10.1984.
- The density of vegetation is 0.10 to 0.20.
- The Divisional Forest Officer, Guntur has certified that area proposed for diversion does not forms part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Corridor, Elephant Corridor etc., and also does not affect any monument of Historical, Religious, Archaeological and Recreational importance inclusive of Wildlife Sanctuary and National park.
- The Divisional Forest Officer, Guntur has stated that the requirement of forest land as proposed by the user agency is not unavoidable and bearest minimum for the project.
- · The Divisional Forest Officer, Guntur has recommended the

proposal in part-II.

The Conservator of Forests, Guntur has not inspected the proposed area for diversion, as the area proposed for diversion is less than 40 ha.

The Conservator of Forests, Guntur has agreed with the information given in part-II by the Divisional Forest Officer, Guntur and recommended the proposal in part-III.

The proposal has been uploaded in Ministry's website and unique no. FP/AP/QRY/37852/2018, Dt.24.12.2018 generated and the acknowledgement slip generated on the web portal is enclosed.

Both, the Divisional Forest Officer, Guntur and Conservator of Forests, Guntur have recommended the proposal. However, it is submitted that, the proposed quarry lease is adjacent to newly proposed quarry lease of Sri Dara Appa Rao over a forest area of 4.49 Ha and existing quarry lease of Sri N.Sivaram Prasad over forest area of 1.75 Ha. Further, all these three cluster quarry leases have indicated individual approach roads. In this connection, it is submitted that, since, approach road for existing quarry lease was already permitted, the newly proposed two quarry leases can make use of the permitted existing approach road duly forming the connectivity from their proposed quarry leases to existing road, instead of proposing individual roads.

In view of the above, the proposals for sanction of quarry lease for Road Metal & Building Stone over an extent of 4.78 Ha. of forest land in Compt. No. 127 of Kondaveedu RF of Ameenabad Beat, Perecheral (V), Medikondur (M), Guntur in f/o. Sri Kunam Brahmananda Reddy, Ongole, Prakasham District, in (4) sets along with required information and maps are submitted herewith duly recommended the proposals in part-IV, for favour of information and necessary action.
