




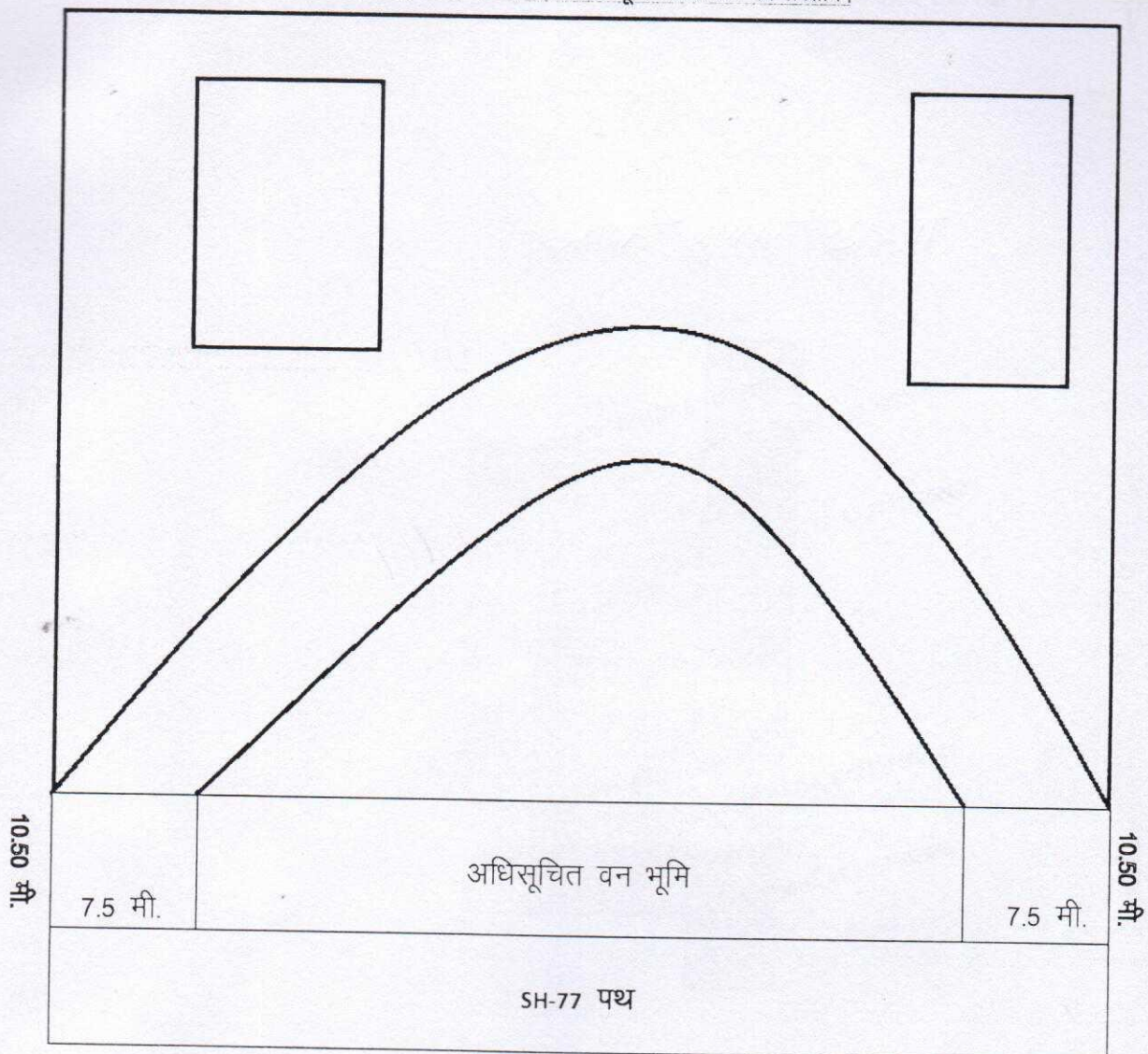
For the purpose of establishing retail outlet (Petrol Pump) of Indian Oil Corporation Ltd. (IOCL) on the Plot No.-466 & 469, Khata No.- 560 Mouza-Akhtiyarpur, Thana No. 102 in Purnea District, a proposal for diversion of 0.01575 Hectare of forest land has been submitted by Mr. Deepak Kumar Bhuiyan s/o Sri Bhundhan Bhuiyan, Village-Sarsi, P.O.-Sarsi, P.S.-Sarsi, Dist.-Purnea under Forest (Conservation) Act 1980. I have inspected the site on 18.11.2021 with Range Officer of forest, Banmankhi and the representative of Mr. Deepak Kumar Bhuiyan. As per the proposal, the proposed site of Petrol Pump is just along side of Forbesganj-Raniganj-Sarsi-Mirganj Road on SH-77" which is a notified forest. For entry and exit from the road to Pump site, 0.01575 Hectare of forest land will be required to be diverted, the calculation of which is attached with the proposal. For developing entry and exit path from the road to the pump site there are no trees to be felled.

During inspection no endangered/unique species of flora and fauna have been found. Also, no protected archaeological/heritage site/ defense establishment is located near the site.
